- I. Welcome to our Electronic Meeting on Google Meet Pres. Brunner. Advice for participation.
- II. January Meeting Minutes (attached) –Robert Hamberg moves to adopt, Mark Jeffreys seconds (U).
- III. Cincinnati Zoo Report and Update Mark Fisher Realignment of entry gateway, new elephant facility ("best in class"), more gardens, parking lot changes, enhanced sustainability all mentioned. Newly surfaced parking lot south of the entrance gates will expand but will not become a parking garage. The plan is affordable and will improve safety for pedestrian crossings, with a passage to be built in the future. Lots of rezoning is required to achieve these improvements and community engagement has been ongoing. The Festival of Lights will be operated with timed-entry tickets from now on, this was a COVID lesson that was positive, allowing much more controlled vehicular traffic and

smaller crowds. Ioanna Paraskevopoulos asked if the Zoo is asking for any tax incentives, Mark Fisher said no, this is City land and the Zoo is a tax-free entity, but since the lot at Euclid will require another traffic signal, they will ask the City for some help with that. Ioanna also wanted to know how Avondale feels about the changes, Mark said that they are supportive, and everyone wants traffic to be calmer. She asked if the land being developed is vacant, Mark said yes. Peter Block asked if this development will extend the perimeters of the Zoo's footprint, Mark Fisher said that the parking lot will expand the footprint a little, paving over gravel with asphalt, otherwise, there's no expansion, but improvements within. Planting ambitions have been pulled back from an earlier plan, now 1.2 million plants are projected. Peter hopes that the Zoo will not "become larger" so as to not impact neighbors negatively. Brendon Cull thanked Mark for coming to present to us and asks that Mark Fisher connect with Mark Jeffreys to coordinate with our safe streets initiatives.

- IV. Golf Outing Event John Whedon (report attached) John asked for volunteer support of this event and gave a history of past events. You don't need to be a golfer, come for the after-golf dinner! He's hoping to play this August (a group of regular participants played in August 2020 without a making it a fundraiser.) CANS is slated to be the beneficiary. John Whedon recognized Joyce Rich for her past support and asked that someone pick up her position. Pres/ Brunner asked for a volunteer event captain from within the Board, activites includes 4 meetings, gathering of raffle prizes, hosting the day-of-event (when 90 golfers can show up), sponsors engagement such as TriHealth, car dealerships. Experience is not necessary.
- I. NSP Application Discussion Pres. Short presentations were made by people who proposed ideas for funding. John Osterman has volunteered to work on installing a roof to cover the Plaza shed with support from CBA, so that item is removed from funding consideration. Malcolm Montgomery and Treas. Checco suggested consideration of Brian Duffy's suggestion to use NSP funds to cover already budgeted items in a year of low revenue. The timeline is for expenditure is by June 30. Pres. Brunner created a poll in the Chat bar, and as a community we'll vote for our choice in March. Tonight's informal, non-binding survey tallies: Wednesdays in the Woods 3, Drive-in movie 2, Ambassadors 4, Radar signs 3, Business District utilities study 2, Already-budgeted expenditures 4
- II. Financial Committee Report and motions Treas. Checco A series of motions by Treas. Checco (attached) to adjust the 2021 budget to be in accord with new data. Motions 1, 2, 3 (concerning CTM facilitation of Clifton Community Fund fundsdistribution from Greater Cincinnati Foundation by GRC, Brendon

Cull seconds.) Vote (U). As a practice Peter Block suggests an Executive Committee review any funds intended for CCF projects that come in to CTM for redirection to CCF contractors. Motion 4, 5 (concerning Golf Outing line item and CANS as beneficiary) by GRC, Mark Jeffreys seconds. Vote (U). Motion 6, 7, 8 by GRC (concerning purchase of an up-to-date Chronicle mailing list which the Treasurer will personally purchase, and work to reduce addresses to match our current 5000 mailing), Robert Hamberg seconds. Vote (U). Carolyn Miller suggests enlistment of neighbors on their known streets to help scrub lists.

- III. Treasurer's Report Treasurer Checco: (Report attached)
- IV. Clifton Chronicle Report Secy Checco (Four documents have been shared with the Board for pre-reading including the 2020 financials prepared by Treas. Checco, all attached.) The committee met in early January, assignments were made for Spring issue. Tom Lohre has created a QR code to have prominent position in the print version that will make easy to find the Online Chronicle. The Spring issue will list all Board members and committee chairs. A suggestion has been made to survey members about who would prefer to receive only an electronic version. Ad sales currently cover costs, but we'd like to explore other sources of revenue, for example soliciting sponsorships of ads by Clifton residents for businesses that can't afford them a la "Clifton Cares".
- V. Parks Committee Mark Jeffreys: Motion for Appreciation of Parks Staff (attached) Peter Block seconds (U). Treas. Checco noted that Ken Casey who worked on the Mt. Storm project has passed away this past month, so this expressions of appreciation is timely. Malcolm Montgomery agreed this is important, especially appreciation to Director Kara Kish in a difficult year.
- VI. Transportation and Public Safety Update Mark Jeffreys. For the Road Diet, the State of Ohio will approve funding for no projects for 2021, so we'll reengage to see if federal funds might be available. Vision Zero projects were submitted to the City, our DOT is reviewing our recommendations. The Temporary Bike Lane on Clifton Avenue is looking for funding, late-March creation is anticipated, using durable markers (not cones).
- VII. Caretaking and Beautification Statistics Treas. Checco postpones his report to next month, his Spring Chronicle article will contain some highlights. Pres. Brunner asks for Capt. Gregoire to be invited to the March presentation.
- VIII. Library Update Jeanne Strauss-DeGroot (report is attached) Update on Library Facilities Master Plan, listening sessions have been organized for each

community within the 5 planning zones. Clifton is in the central zone. She shared a link so that you can register to receive an invitation to that session: https://www.youtube.com/playlist?list=PLCJp4_DkJvqrpzXIG7h0IGM4Jy VNtdmKC Winter Check Out Challenge was explained; and shared Friends of the Library updated criteria for donations of materials.

- IX. Communications Committee Chris Harding. A Jan. 8 meeting was held for orientation and discussion of problems. What should our organization's messaging be? Required will be better content about what our Board is doing, calling on committee chairs to provide content and images. Other topics discussed were updating of website, discussion of Google Suite, its cost and novice experience, possible CRM tools (how would that involve the mailing list, membership, volunteer opportunities, marketing...) The media kit for Chronicle has been added to our website. Pres. Brunner suggests his meeting very soon with Chris Harding, John Osterman and Malcolm Montgomery.
- X. Arts and Culture Committee Update Peter Block. Off Ludlow Gallery is doing well, just needs more staffing. Sean Mullaney - The Gallery Gift Show was up 28% from last year's holiday show which was already a success. "Drip" is the current exhibition about coffee, and visits to the gallery can be scheduled. On March 5 Rick Malette's show opens. A Call to Artists will be coming out soon for the project in the alley between The Bohemian Hookah Bar and D Raphael.
- XI. Clifton Community Planning work Pres. Brunner. We're trying to drive up survey results, he will send out another email to increase from the current 150 participants. Next Monday is the committee meeting, working groups will be created for areas of interest (business district, parks...) Email Pres. Brunner to let him know of your interest to participate on the committee.
- XII. Governance Committee Bylaws Review Work Malcolm Montgomery invites participation on this work, contact him at <u>Malcolm-CTM@edutech.us</u>
- XIII. Trustee, Committee, Liaisons Announcements: Housing and Zoning The 321 Resor Avenue property is going before the Planning Commission about a variance concerning lot size. The City staff is supporting the decision, there have been some questions and concerns expressed from neighbors, and communications need to get in to the City before Feb 5.
- XIV. Community Questions/Concerns: Catherine Hamilton Hicks asked if the Road Diet project has a final design chosen? Answer: median down the middle, 2 bike lanes on one side, but since there is no funding available, the pressure is off for any immediate progress on the project.

- I. Welcome to our Electronic Meeting on Google Meet Pres. Brunner. Advice for participation.
- II. December Meeting Minutes (attached) Robert Hamberg moves to adopt, Treas. Checco seconds (U).
- III. New Officer Elections Pres. Brunner. Candidates are Joe Brunner/ President, Gerald Checco/Treasurer, Secretary/Jan Checco, Vote: (U); For Vice President 1 and

Vice President 2, three candidates presented: Robert Hamberg, Malcolm Montgomery, Ioanna Paraskevopoulos. Vote results: Robert Hamberg is VP1, Ioanna Paraskevopoulos is VP 2. (list of officers attached)

IV. **Committee Chairs Elections, Discussion and Vote on** Motions to Create and/or Disband Committees Elections -Pres. Brunner: Slate was presented. Discussion of split of the labor-heavy Website and Social Media Committees. Brian Duffy suggested a study towards a plan of how to coordinate this activity and create guidelines. Treas. Checco thinks Social Media relates to the work of the Membership Committee. Brian Duffy says that all of the committees need to be able to be served by all of our communication services (Social Media, Website, emails, Chronicle) because it's how we all connect with our community. Ioanna Paraskevopoulos says that she received requests from all committees as well as from organizations outside of CTM. A "Communications Director" could be necessary, Malcolm Montgomery and Teresa Hoelle agree that we need strategies for all of the outbound messaging. Chris Harding thinks a planning document would be a good thing to coordinate this activity, and he volunteers to launch the work, posting in Chat "If anyone else wants to participate in the communications team meeting, email me at hardingc.3630@gmail.com." Secy Checco suggests that at least one Vice President should participate in this team as well. Our Education Committee needs a chair, Brian Duffy offers his service and Robert Hamberg will also be on the committee. Treas. Checco moves that we change the name of the Beautification Committee to "Clean and Safe Committee" because of the true nature of the work is caretaking activity, not just about pretty things. Brendon Cull asks if that would make Public Safety part of this committee, Treas. Checco says that the Clean and Safe Committee concerns are not about traffic but rather about crime issues. Peter Block asks for other words than "Clean

and Safe." JBC suggests "Caretaking," Teresa Hoelle suggests "Caretaking and Beautification." Vote on Caretaking and Beautification Committee renaming: (U). Treas. Checco announced April 10 and 11 to be the dates for Spring Clean-Up. Pres. Brunner suggests that we rename the activity relating to CTM communications, Brian Duffy suggests that this work represents more than a full time job and also includes marketing. He says the vision for coordination exists, but the manpower is lacking. Ioanna Paraskevopoulos suggests building a committee with many participants and then empowering them to work with a shared platform. Robert Hamberg suggests that we take time for this discussion off line very soon to organize this as well as internal communications strategies. He will help, so will Teresa Hoelle, so will Brian Duffy. Peter Block suggests that we might want to pay someone to oversee this communications work, just as we have for publication of the Chronicle. In the interest of having a Board member chairing committees, Malcolm Montgomery suggested twice that Peter Block co-chair the Arts & Culture Committee. Peter Block declined. Vote to accept the slate of 2021 Committee Chairs as finally presented (see attached): (U) Treas. Checco proposes creation of a "Finance Committee" with the Treasurer as Chair, and including members from the Arts & Culture/Art Gallery (Joyce Rich), Chronicle (Vicki Black) and Membership (Teresa) committees, seconded by Malcolm Montgomery Vote: (U). (List of chairs attached)

V. Liaisons Elections Elections - Pres. Brunner: Slate presented, additional volunteers were recruited to fill the spots Clifton Community Fund (Teresa Hoelle and Peter Block), Tri Health/Good Sam (Joe Brunner), UC Health and Uptown Consortium (Brendon Cull), Neighborhoods of Uptown (Malcolm Montgomery) Pres. Brunner moves, Robert Hamberg seconds Vote: (U) (list of Liaisons attached)

- VI. **Event Captains Elections and Discussion about when to** reactivate 2021/2022 Events Elections - Pres. Brunner: Should we appoint captains or wait to see if we are able to produce any activities? Robert Hamberg wonders, in the interest of inclusion, if there's an advantage in engaging leaders even if there's no certainty of an event happening. Patrick Borders has expressed interest in planning for something like a self-guided Clifton Home and Garden Tour in 2021. Pres. Brunner will plan the Lantern Walk for Fall 2021. Peter Block asked Joyce Rich to lead CTM in production of Holidays On Ludlow in 2021 in support of CBA, and she agreed. Treas. Checco volunteered to organize a Memorial Day Parade and Picnic. Robert suggests we table event captain appointments until February. All agree.
- VII. Discussion and Vote on 2021 Meeting Dates Pres. Brunner. Dates proposed (list attached) Pres. Brunner moves, second Robert Hamberg. Vote (U) Brian Duffy commented that we need to review any activities that need to happen by certain deadlines so that we don't need to call special meetings.

VIII. Treasurer's Report and 2021 Budget Presentation –

Treasurer Checco: (Report attached) He has shifted some seed money for events with potential in Fall 2021. Currently, membership fees and donations are our only source of revenue. Treas. Checco moved that the new Membership duration agreement we passed in November 2020 be amended to state that "A renewed membership will have a duration of 12 months (annualized) starting from the date of renewal." Vote: 12 Y, 1 A Motion passes. Teresa Hoelle agrees that with the annual membership list refreshed, this renewal practice will be manageable. Mark Jeffreys asks if the Golf Outing in August could be practical? Brian Duffy reminds everyone that we give away 70% of our annual golf outing proceeds to a charity, so the net to CTM has been about \$3K. The Treasurer suggests that with the current pace of COVID vaccinations, there probably will not be crowded activities encouraged in summer. Peter Block asks for an explanation of the difference between cash flow and reserves. Treas. Checco reviewed that we cashed out one Certificate of Deposit for \$24K last year, and that he would prefer to not to cash out our remaining one for \$40K. Peter Block wants to make sure that we understand that we have approximately \$60K in reserves. Brian Duffy asks about the Chronicle's pay-in-advance fund line. He points out that our shift to the new newsprint with color format has made the Chronicle a potential new revenue source for CTM. Treas. Checco makes a motion that the Chronicle Editor/Publisher Vicki Black receive a \$1K bonus based on her excellent results for ad sales this past year, which pulled the Chronicle out of a \$8K deficit from 2019 and put it into a \$8K profitability in 2020. Brian notes that we increased Vicki Black's pay last year because we knew there would be extra work. Treas. Checco suggests a formalization of an offered bonus (a % of the net gain from ad sales at the end of every year.) The \$1K that he proposes for a bonus in 2020 reflects 25% for the work she has accomplished in that year. Brendon Cull asks for a better understanding of the Chronicle financials. Treas. Checco can create that and present it to the board in February, with projections based on a profitable activity. Vicki Black's pay is \$1400 per issue. Peter Block has reservations about a bonus becoming an expectation, so if we think she's underpaid we should pay her more. Robert says this bonus is a recognition of excellent work in the past year, an incentive that can lead to increased pay. Malcolm Montgomery suggests that the balance between editorial content and ad content is important. Treas. Checco says that the Chronical committee is responsible for insuring that balance and he suggests that we are already paying Vicki what she has asked. The bonus would be an insurance that the paper will pay for itself. Treas. Checco moves that we adopt the Vicki Black's \$1K bonus proposal. Vote: 10 Y, 3 A. Motion passes. Brendon Cull asks for this topic to come back to the Board through a report, and Treas. Checco says an update about Chronicle operations and budget will come from the Chronicle committee. He also wants to correct that Housing and Zoning will have an additional \$500 put back into its line item (making a total of \$1000) because of the costs associated with making an appeal. Malcolm Montgomery is concerned about the line item for Ludlow Avenue business district expenses to be covered by CTM. CBA income from its Merchants Lot lease can cover costs for Cliftonfest, Holidays on Ludlow and Clifton Plaza programming - all business district centric - and he suggests these could be removed from our CTM budget because CBA can pay for them. Malcolm Montgomery moves we remove these, but there is no second. Robert Hamberg says that there's nothing stopping us from changing those line items without a vote. Treas. Checco agrees with Robert Hamberg's point and says he will meet with CBA to find out if they need our financial support on those activities. Brian Duffy asks about the \$2K reserved for the 2021 House Tour, Treas. Checco suggests that it's seed money in case anything can happen towards that event in 2021, and at any rate might be needed for planning. Peter Block notes that CBA has made big investments in what's important and good for our neighborhood and he wants to make sure they know we are willing partners despite our financial situation. Vote to accept amended 2021 Budget: (U)

- IX. Governance Bylaws Review Work Malcolm Montgomery. He has put together a list of things to reconsider for the bylaws review and is soliciting participants for the committee. Pres. Brunner will be helping on the committee.
- Clifton Chronicle Content Creation for Spring and Summer
 Issues Secy Checco: Invitation to join the committee for

content creation and proofreading. Emphasis on "Rebound, Recovery, Support" especially to Schools and Businesses. All CTM Board members are asked to offer reports of their committee's accomplishments, and also outlines of their plans. The general public is invited to submit texts at any time. Deadline is Jan 31 for editorial stories. Send to Vicki Black, that link and more info can be found on CTM Website.

- XI. Clifton Community Planning work Pres. Brunner: Look at the survey on the City Planning page on the City of Cincinnati webpage. <u>https://www.cincinnati-oh.gov/planning/neighborhood-plans/ongoing-neighborhood-planning-processes/clifton-neighborhood-plan/</u> The survey has been up for a while, and we'll need to move on to the next step. Everyone should take the survey there, we need more responses. Next phase will be deeper thinking. An email will be sent out to solicit more participation on the survey.
- XII. Vision Zero 2021 Clifton Projects – Mark Jeffreys: The Board has done prereading of the project proposals (attached) and the City wants our vote on these. He moves that we approve, second by Brendon Cull. Brian Duffy wanted more attention to the McAlpin/Woolper/Clifton problem. Pres. Brunner reminded us that a study request has been made to the City for that intersection. Robert Hamberg lives on Lowell Avenue and knows that it's a crime hot spot with vehicular speeding. He wonders what the process is for making decisions about addressing problems when deterrents are needed. Policing data can be added to the discussion. Mark Jeffreys says that these issues can be raised in the next quarter when there will be more contact about problem solving. Brian Duffy wants to see more effective community-voices collection, because he knows we can get better at what we need to do. Mark Jeffreys says we can start going door-to-door to collect feedback,

especially when we begin the Community Plan work. Vote to approve the projects as presented: (U)

XIII. Community input: Kevin Marsh asks about when to expect the NSP project vote for 2021 and wants to know what's happening with proposals. Pres. Brunner says the deadline is mid-February, we have some ideas to develop and we will continue to welcome all ideas the community would like to submit.

Tax Filing

- Gerald working toward completing the filing by mid February (deadline in July)

Goals for 2021

- Explore other sources of funding, including Estate Planning and Grants
- Train Gerald's replacement as Treasurer (term ends 12/31/2021)
- Work with Chronicle to clean and expand mailing List
- Find a permanent replacement for Quickbook and evaluate integration with Membership needs.
- Motion 1: to accept funds from CCF and disburse according to CCF stated intent for the funds. <u>Background:</u> The Clifton Community Fund is a civic association with one of its goals being to fundraise towards projects beneficial to the community of Clifton. The disbursement of their funds is made through Greater Cincinnati Foundation (GCF.) GCF can only disburse funds to non-profit organizations that are registered with GCF (CTM is one such org.) For example, in 2020, CCF gave CTM \$4,000 for CliftonCares to be used by Clifton Business Association (CBA) who managed the project. This motion seeks the formal approval of the CTM Board to do what has traditionally been done - empowering the Treasurer to carry out CCF's intentions.
- **Motion 2:** Work with the three civic associations in Clifton CTM, CBA and CCF- to create a general MOU for our collaboration.

<u>Background</u>: Clifton has three major civic associations that have worked together on a variety of projects for the betterment of the community. For example, in 2020, these groups collaborated on CliftonCares, Telford Seating area and the Shakespeare Bench installation, picnic tables moving to the Plaza, volunteer outings, development of a Safety Plan. This motion is to create a framework of collaboration through an MOU that will formalize our cooperative relationships.

- Motion 3: amend the 2021 Budget to reflect our CCF decision (Motion 1). <u>Background</u>: Following up on Motion 1, CTM has already received in 2021 two checks from CCF - one for \$1,300 to support an art project of wrapping an utility box on Telford with a historical image, and a check for \$1,500 to purchase 3 picnic tables for Clifton Plaza. The Finance Committee recommends the creation of two line items for the same amount of \$5000, one in Revenue and one in Expense, as placeholders to receive and disburse all potential CCF funds. The Finance Committee further recommends no processing fees, as the projects funded by CCF benefit the entire community and are consistent with CTM mission.
- <u>Motion 4:</u> Amend the 2021 Budget to reflect the Board's decision of organizing the Golf Outing <u>Background</u>: The Golf Outing Event Committee has decided to move forward with the organization of the event in for August 2021 (pending confirmation of the lifting of the pandemic restrictions). The Finance Committee recommends adjustment of the budget to reflect Revenue and Expenses of this event.

- Motion 5: to restate the 2020 decision to make CANS the beneficiary of the Golf Outing. <u>Background</u>: In 2020, the Golf Outing was cancelled. We hope that it can be held in 2021. This motion is to confirm that the beneficiary of the outing is still the organization intended for 2020, the Clifton Area Neighborhood School (CANS).
- **Motion 6:** To accept a donation to purchase an up-to-date mailing list to be used for the Chronicle.

<u>Background</u>: The Chronicle mailing list is inaccurate with some data more than 15 years old. The motion is to accept a donation to purchase a new list that is guaranteed to be at least 95% accurate. This list would include names (i.e. not generic "resident") and can be shared with the Membership Committee, the Communications Committee and for other CTM needs.

- Motion 7: To evaluate if the new mailing list needs which will need to be scrubbed to eliminate enough addresses to get back to the affordable 4800 addresses.
 <u>Background:</u> The new mailing list will have around 5,100 addresses. This motion proposes that before using the list, the Finance Committee (with whomever else wishes to help) inspect the list to assess if some addresses need to be scrubbed out that may fall out of Clifton boundaries or have other problematic issues (such as large apartment buildings where a stack of Chronicles are just left in building lobbies...)
- Motion 8: To come up with a recommendation to the Board if result of motion 7 still results in more names that before with old mailing list.
 <u>Background</u>: The new mailing list has around 5,100 addresses. If the Chronicle is sent to additional addresses it will cost around \$500 more per quarterly issue and result in an overrun of more than unattributed 1300 copies.

The golf committee. Serves substantial hours throughout the year. Responsibilities include securing title, presenting and hole sponsors, as well as collecting up to \$3,000 in raffle prizes. Committee members market the event thru the C Chronicle and local signage including posters and yard signs. The committee organizes day of event contests i.e. "Beat the Lady Bearcat", "Kids putting" "hole in one" and has organized special food sponsors. The committee is responsible for organizing a post-golf dinner event on the deck at Avon where raffle prizes are awarded and a "Friend of Clifton" is honored. The committee has been made up of following individuals – Tom Dwyer, Joe Huber, John Juech, Joyce Rich, Eric Urbas, Vince Metzger and John Whedon. The golf committee presents it choice for event beneficiary and Friend of Clifton Award to CTM for confirmation.

Finances. Clifton Golf Outing budget includes golf course reservation deposit payable to Cincinnati Rec Commission (\$100), event posters (approx. \$100) and hole sponsor signs (approx. \$500) which have been paid out of event proceeds. Traditionally CTM receives up to a maximum of \$3,000 of event proceeds dependent upon event success.

Chronicle Report to the CTM Board

Feb 1, 2021-01-07 Submitted by Jan Checco, Chair

Discussion and ongoing work, including notes from the Chronicle Committee Strategy meeting on January 7, 2021 via Zoom

Participants: Vicki Black Editor/Publisher, Jan Checco Chair, Gerald Checco Treasurer, Bob Driehaus, Rama Kasturi, Tom Lohre, John Whedon. Absent: Teresa Hoelle

Jan announced the creation of a CTM Communications Committee with a Coordinator - Chris Harding. The Chronicle will be included with this along with CTM Website, Social Media, Emails, and Membership committees. The function of the Chronicle will remain distinct within CTM's ever-widening field of communications. Rama asked if this innovation received a Board vote, the answer was yes, and unanimously. The Chronicle committee agreed that the Spring 2021 Issue would be produced following recent practices and would reserve for later discussion it's function as a CTM Standing Committee (actual status of record.)

Financials from Treasurer Gerald Checco (accounting report attached): The Board has approved a \$1000 bonus to Vicki for her work on stabilizing the Chronicle billing and income. In 2018 there was a gap, but at the end of 2020 we are \$8K in the black, thanks to the close communication and coordination work between Gerald and Vicki. "Follow up" was the key. He projects a 2021 \$5K cost per issue based on anticipated \$2K for printing, \$1K for mailing. To seek additional ad sales we can review what percentage of Clifton businesses are currently advertising and approach those who are not. Gerald will ask Patrick Borders of CBA to help with this research. A CTM Financial Committee has been formed to connect the committees with the most billing and payment activity. Hopefully this network will help to smooth the transition when a new CTM Treasurer will serve in 2022.

Editor's report of stories currently in hand for Spring 2021 Issue and assignment of additional stories including choices from the list generated from Board members: CBA and CCF will submit stories for each issue. Rama will interview Tom Reese of CRC and work with Teresa on a "Clifton Active" theme; Tom will collect merchants' news and format the new Go Vibrant signage for print; John Whedon will write about the 2021 Golf Outing (August 28) with CANS as charity recipient, and he asked to be paired with a CTM Board member for event leadership. He will present his proposal for the event to the Board at the February 1 meeting. Gerald will facilitate an

autobiography by an expatriated Clifton resident, themed to "our international village." The language on the Membership coupon needs to be updated and add a request for "legible writing." To engage more people, Jan will provide a list of CTM Board members and Committee chairs and will develop a "Clifton House and Garden Tour 2021" photo essay for the summer issue, driven by a Call to all Clifton residents via our members list and social media for contribution of photos of their beautification projects from the past year.

Tom Lohre will provide a QR code that allows recipients of the print version of the Chronicle to connect immediately to the expanded online version. This should be put in a very prominent position (front page?) Gerald suggests that when a new issue is published, the updated CTM Membership list can send an email to all that includes the link to the online version. He is researching why some Clifton home addresses are not receiving the mailed printed version.

Schedule of our next committee meeting is February 25, 11:30 by Zoom., noting our deadlines of Jan. 22/ads (final art 1/29) and 29/editorial for Spring; The new cycle begins after Spring Issue lands on March 1. Summer deadlines are April 17/ads and April 24/editorial.

<u>Next Discussions</u>: A question was submitted by email from CCF President Margaret Reich - Could deadlines for editorial content be set at the end of the first week of the month of our production schedule? This allows for any discussion of articles by CTM and CCF Boards to occur at our regularly scheduled monthly meetings, streamlining communications. (To be discussed within the Board and with the Editor/Publisher, understanding the possible repercussions to delivery dates of the Chronicle to mailboxes.)

For future discussion about our mailing list and labels:

• Many addresses have names of people who have not lived at the address for 15 + years. We've received complaints from people that are CTM members who are unhappy that someone else's name is on their label. Possible solutions: Since all Clifton residents receive the Chronicle, in order to avoid laborious recurring updates, we could replace all particular names with "RESIDENT," which is currently the addressee for 90% of the mailing. Or we can buy an up-to-date mailing list with names for every current 45220 residence for about \$500.

• With purchase of a new list, the number of addresses receiving the Chronicle will result in an increased cost, totaling 5199 addresses (411 more addresses than our present list.) A new list can be scrubbed to 5000 (this is the breaking point for a run at the printer, with the next increment being 7500 copies, which would create an unnecessary overage.)

• Other errors in our mailing: The vast majority of elected officials and other "non Cliftonite" special addressees are no longer in those positions. Possible solution: Make addressee generic (such as "Cincinnati City Council Member" instead of the name of that particular person.)

- Let's review our list of advertisers so we do not miss anyone.
- Postage will be increasing (\$0.189 per piece as opposed to \$.185 per piece.)

• Understanding that over time some recipients may opt to only receive the Chronicle electronically, we'll discuss some ideas with Robert Hamberg has to include this kind of service.


