January Meeting Minutes – Jan Checco moves to approve, Robert Hamberg seconds (U)

Treasurer's Report — Tim Maxey presents the January financial reports. January focus was wrapping up 2021 activities—transition of officers and tax preparation. Financial committee will begin meeting in the third week of February.

Police Report — **Officer Shawn Dent.** Violent crimes and burglaries are about the same vs. previous month. Theft from autos is up. There is a trend in theft of catalytic converters. Toyota, Honda, Hyundai, smaller SUVs and electrics are being targeted for the precious metals in these

converters. Thefts are happening on Lowell, Bishop, Telford. Officer Dent reminds the community to be vigilant—use video cameras or video doorbells if you have them, listen for car alarms and look around if you hear them. Thieves will park close to their target vehicle and slide underneath, removing the converter in about 60 seconds. Officer Dent can be contacted at: shawn.dent@cincinnati-oh.gov

CPD5 Letter. Gerald Checco presents a letter asking Cincinnati City Council to move forward with design and construction of the District 5 headquarters. The issue has been ongoing for 60 years with no progress. Councilman Mark Jeffreys informed Gerald that no money was requested for District 5 and will follow up in the Safety Committee meeting tomorrow.

Discussion—Chris Harding asks for background on why the city hasn't acted, asks how else we can spread awareness of the issue. Gerald suggests that by working with the consortium of neighborhoods in district 5, we can push for progress on the topic.

Mary Pat Lienhart asks to emphasize we support an economical approach. The potential location on Central Parkway is advantageous from a financial standpoint, and Mary Pat asks that we attach our previous letters which state this. Robert Hamberg adds that the letter as a half-measure, given that it doesn't include recommendation on a location. Robert adds that the location is important because it provides a good response time for our community. Kevin Marsh would also like to see the board continue to support Central Parkway specifically. Jan Checco and Jayme Ritter would like to see a second letter sent with the location information included. Gerald suggests we can use future meetings to review additional letters and discuss future additional actions we can take.

Motion to accept the letter with amendment with fiscal responsibility comments, along with previous letters sent by CTM, by Jan Brown Checco, second by Mary Pat Lienhart. Vote Y(12), N(0), A(1)

Clifton Recreation Center Report — Jan Checco on behalf of Collin Fitzpatrick. Pottery classes with Queen City Clay instructors will start in March. School day enrichment was a success during the school's Covid-related shutdown, with staff adapting quickly to serve 26 students. CRC is looking for community partnership's with UC's student union building and the Zoo. CRC is looking to add additional programs in martial arts, senior & adult exercise, and music. Contact Collin with ideas or question at collin.fitzpatrick@cincinnati-oh.gov. CRC is open Monday through Friday 7AM—8PM.

Library Report — **Jeanne Strauss-DeGroot.** Winter Checkout challenge is happening, people can participate until February 25th. To register, visit the <u>library website</u> or the branch in person. Registrations get a new tote. With 5+ activities completed, people earn a free library mug or notebook. Take-and-make activities are available for pickup, including a Valentines Day card. Visit the Black History Month display celebrating Black literature and culture. Tax assistance and tax forms are also available at the branch. People get 20 free prints.

Clifton Business Association report — **Genet Singh.** CBA is working to enhance the business district. CBA has new officers—

Membership Report — **Robert Hamberg.** Membership had its first meeting in January and discussed goals. A major goal is expanding membership and contact with the community, and began plans to expand the email list and memberships. Spoke with Vikas Mehta (community member and UC Planning professor) about an idea to canvas the community or engage members for feedback through local businesses and events. Vikas will look into approval from UC to include in a course curriculum. This would be in the fall semester. If there are costs, we will pursue grants to fund it. This plan has overlap with other committees (Communications, Housing) and will collaborate with them in the future.

Chronicle Report — **Jan Brown Checco.** Building on the membership report, every Chronicle includes a membership coupon as a consistent, reliable driver of membership. All members can be content contributors to the Chronicle, and every issue features someone new. In January, the Chronicle renewed advertiser contracts. To aid struggling businesses due to Covid, we offered 20% off for businesses that paid for the entire year (equivalent of one free ad). We are in a good place financially and need just \$2000 to cover publication costs. Adrian Durban and Kroner Dry Cleaners (in Clifton Market) are new advertisers.

Housing & Zoning — Jayme Ritter. City planning is pursuing changes to multi-family zoning, with the goal to increase density. This would allow 2x the units on the same square footage of property, with no changes to other requirements, like parking, setback, or building height. Lots of representation from the community, councils, and developers was present. Community councils are largely against this policy, primarily because it is not appropriate to do a one-size-fits-all to the zoning code for all 52 neighborhoods. Commission voted 3-3, failing. There have been 22 meetings over 8 months on this topic, including Invest in Neighborhoods. Liz Keating will take it to the City Council and discuss if they will vote on it. They will need 6 votes to approve (as opposed to the normal 5).

NSP Program — **Mary Pat Lienhart.** Last date for submitting a proposal is March 11, 2022. We need to have a vote of the community-at-large, proposals need to be ready by next meeting. Gerald and Mary Pat are working on this. There is a limited amount of funds (\$7638) we can apply for. If we have multiple ideas, we will need to rank ideas to allocate funds. NSP can be used for a variety of things, including beautification or education. It cannot duplicate an existing service from the city.

Gerald is preparing a form for community members to submit officially. Current ideas discussed include sponsoring CCAC movies on the plaza (via Leslie Mooney), Cliftonfest (via Molly Gray), Clifton Plaza outdoor dining banquet (akin to Dîner en Blanc), and the Memorial Day picnic.

Motion by Jayme Ritter to have an additional meeting on Feb 28 to review NSP presentations, second by Mary Pat Lienhart. **Vote (U)**

Other Committee Announcements: Brendon Cull shares information about a serious accident at Clifton and McAlpin. Pedestrian safety is a significant issue, and Mark Jeffreys will host a roundtable with experts from around the country—March 1, 6:30 at Hirsch Rec Center on Reading Road.

Mary Pat Lienhart shares that Clifton was underrepresented in getting snow removal and street cleaning vs. neighboring communities. John Osterman shares that there is an app to request having your street plowed.

Trustee, Committee and Liaisons Announcements:

Chris Harding is moving to Pleasant Ridge. This will be his last CTM meeting.

Brendon Cull is hosting a huge Super Bowl party—Big Bengals Tailgate at the Banks is looking for staff. Contact Brendon if want to volunteer on Sunday and make some tips.

Joyce Rich – Off Ludlow Gallery will begin offering classes this month. There will be classes on Bookmarking (Feb. 12th this Saturday 12-3). Sign up on Facebook or contact Joyce. Barb Smucker will host a collage workshop from 1-3 on Feb. 19th. Open to all ages.



NSP Proposals

The Neighborhood Support Program (NSP) funds resident-controlled projects, improve the leadership capacity of community councils and recruit, training and increase the productivity of volunteers. The funds are available for projects that are planned, implemented and evaluated by eligible community councils. Proposals are presented to the community during an open meeting allowing community residents to vote on proposed activities/projects (residents may vote whether registered CTM members or not – documentation of sign in and resident eligibility is required). The proposals should have successful outcomes that the council can manage.

The city has identified the following categories as acceptable project areas:

Categories

- Neighborhood Leadership Development Activities (i.e. membership drives)
- Communication Projects (i.e. newsletters, websites)
- Neighborhood Improvement Activities (i.e. beautification, clean-up and conservation)
- Educational Activities (i.e. educational programs for youths/seniors)

- Neighborhood Services (i.e street calming)
- Problem-Solving Projects (i.e. business district plans)
- Other/Quality of Life (i.e. health fairs/health services)

Operations

The projects among other things should not duplicate services that are already currently available, give direct funds to social services (such as emergency food, housing assistance), endorse or promote political candidates or their activities or fail to serve any public purpose.

Expenses

A complete budget should be provided. There are limitations to certain expenses (food, prizes, publications, routine operating expenses). In addition, if there are any capital assets (equipment and/or supplies that have a useful life of three year or more and cost exceeds more than \$1500) these must be stored in a publicly accessible location.

Process

Proposals will be submitted to CTM no later than February 25, 2022 to be voted on by the Clifton community at the March 7,2022 CTM Board Meeting. The last day for submitting a proposal to NSP is March 11, 2022. A form has been created to help facilitate the process and will be available on the CTM website. Those voting will have to sign in and indicate if they are a CTM member or not. If not a CTM member they will have to provide documentation to verify that they are a resident of Clifton. The total amount of funds that can be requested from NSP is \$7,638. If there is more than one proposal that is approved at the meeting and the total amount of the funds requested of the proposals exceeds \$7,638 than we will have to rank order the proposals. One option to help assess how many projects can be submitted to NSP is if the proposals have some detail of expenses. If there are duplicate expenses among the proposals, we may be able to consolidate them to lessen the total amount of funds being requested. If there are other options for maximizing the number of proposals forwarded to NSP we can discuss at our February 7, 2022 CTM Board Meeting. Once decided, the CTM liaison to NSP will submit the voted proposal to NSP for their review. No expenses can be incurred on any proposal until CTM has a signed contract with NSP.
