#### Police Report

Neighborhood Liaison Officer Nick Hageman reported that D5 HQ would be temporarily relocating to a leased location in College Hill on 5837 Hamilton Avenue. The goal is to be fully relocated by end of March 2018.

Any service impact from being located in College Hill? No, we have officers assigned to different beat patrols that are spread around the district. It would only cause people to travel further when they needed to come to the district to do police business.

How much time does a patrol officer spend at the station? Maybe about 90-120 minutes during a shift (preparations, roll call, check emails, completed & revise reports, meal breaks, bathroom, etc.)

Does D5 have any sub-stations? There are 4 at this time: Stop N Go on West McMillian, Thortons on Colerain Avenue, Winton Place on East Upworth, and the College Hill business district. They are not what they used to be. No phones, no computers.

Crime stats for 2017 for District 5: Increase in violent crime by 6% (38 up to 40). Property crime 50% (306 up to 353). Total crime up 14% during the year. December stats: 88% decrease in thefts. Total property crime was down 40% in December.

This time of year police do see an increase in auto-theft due to people warming up their vehicles.

#### Introduction of Wade Walcutt - new Director of Cincinnati Parks

Trustee Rama Kasturi invited Wade to attend our meeting after interviewing him for the Winter 2017 Clifton Chronicle article.

Wade has been working for about 6 months now after moving from North Carolina in a similar role there. He feels very welcomed by Cincinnatians. He seeks to partner with local communities.

Any special priorities at this time? None. Right now, he is just exploring the organization and its relationship with City. He wants the team members of the organization and the residents to fully appreciate all the impacts that the Parks Department makes on people's lives.

What types of budget restraints are you facing this year given the City is facing a \$20 MM deficit in the coming year? Have not gotten to that level of detail at this time. We do have deferred maintenance in our parks.

What are the odds that we can open up the Nature Center at Burnet Woods on the weekends for providing service to children and others? What can the community do to make this happen? He will work with his staff to understand what could be done to achieve this.

If there are any changes coming to Burnet Woods, can you please let us know? Yes, he will.

What is happening with the Master Plan for Burnet Woods? It is about 10 years old. Over time, needs change as does the community. These are the community's parks; therefore, he wants his organization to engage with the community to understand what's next.

Clifton Branch Manager Lisa Hamrick reported that during early February the Howell Avenue development visioning from UC students will be on display at the Branch.

# **Treasurers Report**

Treasurer Buddy Goose reported on monthly results. Income - \$ 2501.30. Expenses \$13,264.43. CTM has total assets/reserves of \$71,179.

Full year results: \$55,400 income. \$56,800 expenses. We are better off that what we anticipated based on our 2017 budget.

Motion to accept the Treasurer's report passed.

#### 2018 Budget

President Celsor presented the 2018 proposed budget. Revenue - \$78,400 Expenses - \$61,075

Discussion:

- In a House Tour year, we should expect revenue to be much higher than expenses. This allows for coverage until next House Tour.
- Considering spending money to do Plaza planting bed maintenance with a contractor. We will discuss proposals/options at future meetings.
- Some expense lines are in the budget but do require another Board vote before spending. Examples: Zoning decision appeals, Arts & Culture spending of \$1500.
- Trustee Joyce Rich advised that there was no money left with our City branding project for logo designs. Therefore, a House Tour related and Golf Outing related logo require funds. Would take about \$250 350 for each.

#### Transportation & Public Safety Committee

Committee member Kevin Marsh advised the following update regarding CPD District 5 HQ.

In late December, some members of City Council announced an ordinance to fund a new permanent HQ in College Hill. Based on the surprise nature of this ordinance, CTM notified many council members that Clifton had not had any input into the process per requests since January 2017. This ordinance failed to pass the Budget & Finance Committee during the last Committee meeting of the year.

From today's City Council Budget & Finance Committee, the Councilmembers voted to move ahead with a community engage process to determine a location for D5 HQ. Interim Director of City Planning, Katherine Keough-Jurs stated that it would take a couple of months of community engagement. The process would involve analysis and decision making with transparency. There will be at least 2 community meetings. Then, City would limit site choices and then do detailed analysis for each option after that. City Manager Harry Black stated that the administration intends to follow a process like what was used to select the District 3 HQ.

All staff of D5 HQ will be temporarily moved by end of March to a leased location in College Hill per report of Chief Issac to the Committee today.

Community member advised that they felt College Hill is a good choice. What are the criteria for selecting a location? This is not known.

#### <u>Clifton House Tour</u>

Trustee Adam Balz reported the following for the House Tour: Next meeting is Tues, Jan 9 Pressing items for completion:

- 1. Finalizing the list of houses for the tour with commitments from owners.
- 2. Completion of input for a marketing mailing on Jan 15.

Trustee Buddy Goose seeks contact information for the confirmed homes to gather feedback from homeowners on any work they have done

Trustee Eric Urbas said he will continue to do the house maps. He believes that the historical write ups of the houses may or may not be done UC students as before. He has contacted some UC professors. We may need help in this area so we are seeking volunteers to avoid having to pay for this historical write-ups. Please email <u>contactctm@cliftoncommunity.org</u>. Trustee Kasturi advised that some of the houses selected have previously appeared on the Cincinnati Historical Tour so we may get some history form there.

Trustee Kevin Marsh agreed to write the article for the Spring Chronicle issue. Trustee Balz asked the community to provide any suggestions for companies that might be interested in advertising.

Clifton Area Neighborhood School (CANS) Update. Open House – Tues, Jan 23, 4:30-6pm. CPS has hired a Program Manager for CANS. Kelley Bagayoko. Parent requested this week to move 3 children into the school – 2 PreK and 1 Kindergarten.

Trustee Marsh advised that City Council action on CTM's Bicycling Infrastructure letter from May 2017 sunset at end of 2017, and the DOTE report was written. Per DOTE, we need to send the letter again. Without objection, the Board agreed that Kevin Marsh will prepare the letter for the President to transmit to City Council, Manager, and Mayor.

Marsh also shared the Transportation Committee continues to work on the pedestrian safety issues at the intersection of Brookline and Glenmary with community and City DOTE.

Kip Eagen thanked Eric Urbas for all his service as President of CTM the past period.

Michele Murphy asked about the DePaul Cristo Rey High School community meeting from 4-5pm on Jan 16 at the school. President Celsor advised CTM is aware of the meeting and the Housing & Zoning Committee is focused on this project. Celsor said she would be attending.
