**May Meeting Minutes — Mike Roller.** Jan Brown Checco moves to approve, Mary Pat Lienhart seconds (Yes: 9, Abstain: 2)

**Treasurer's Report — Tim Maxey.** Tim Maxey is resigning from the Treasurer position but will remain on the board.

**Police Report — Officer Shawn Dent.** There were two felonious domestic assaults in May. The most concerning stats are the burglaries and breaking & enterings—7 in May vs. 1 the previous

month. A lot of this activity appears to be happening around Senator Place. Any leads would help with ongoing investigations. There were 2 auto thefts near the Shell station.

Camera Registration Program. Sergeant Ploehs requests that residents register their Ring doorbells (and other home cameras) with the City of Cincinnati. This will help officers know if nearby residents may have camera footage to help an investigation. Residents can register their camera doorbells at [this website](#). Additional information can be found in the camera registration's [FAQ section](#).

Speed studies in District 5 continue with resident requests for traffic calming. City Council is taking notice as well. [Contact Officer Dent](#) to recommend locations for a speed study.

Gérald Checco asks about the overall rise in crime. Sergeant Ploehs explained this is primarily due to the 400% rise in rape vs. last year (5 vs. 1). Jan asks for additional information so we can help in any way possible to ensure our neighborhood safe.

Zeeshan Tayeb asks about the mental health implications for crime. Sergeant Ploehs pointed out that there is a mobile crisis unit to help with this. In addition, regular officers have laptops that allow people to talk with mobile crisis to get help and be assessed. Officer Dent mentions recent training & technology for people with special needs. People can [email Officer Dent](#) with requests for more information. Jeanne Strauss-deGroot asked for more information from the pilot with social workers in the field. Pilot is from July-December and we will have more information in the coming weeks.

**Library Report — Jeanne Strauss-DeGroot.** Summer programs have started, kicking off with a summer party for kids & families. Program lasts through August, with the chance of winning a variety of prizes.

Upcoming special events. Avengers escape room. July 2: Big Kids explorer club (sun theme). Dancing on the globe program. August 2: Paint like Picasso program. August 16: Insects & spiders interactive program. Visit the [library website](#) to see all events.

**DORA Presentation — Justin Halter.** DORA: Designated Outdoor Refreshment Area [presentation](#). Gerald reminds the attendees that this is an introductory meeting for everyone, with much more community engagement and CBA to be involved.

The city is thinking strategically about the last two available DORAs. Clifton makes sense because of a central location and strong geographic distribution. CUF is also being considered.

Rachel asks for more information about waste management, pedestrian safety factors, and supplemental costs for sanitation. The managing entity is responsible for additional waste or recycling bins. The Banks has not seen significant issues due to the DORA. The Banks is

charging establishments \$1 per use to fund the costs—signage, trash receptables, and additional police. New DORAs often engage in fundraising activities to get started.

**Invest In Neighborhood — Elizabeth Bartley.** Presentation on the organization and its activities.

**Memorial Day Picnic— Barry Gee.** The event went well with approximately 400 attendees. Mayor Pureval was in attendance. The Dog parade, Dojo Gelato, live music, and chalk art were popular events. **Neighborhood Cleanup Report — Jayme Ritter.** Beautification efforts before Memorial Day were a success with many volunteers helping make the neighborhood look its best. [Spring cleanup & beautification volunteers](#)

**Clifton Chronicle — Jan Brown Checco.** Exploring ideas on how to get the Chronicle on UC campus to reach more neighbors and students. The next Chronicle theme will be on diversity. The Chronicle team is interested in interviews with people from a different part of the world who have chosen to live in Clifton.

**Arts & Culture — Joyce Rich.** Current gallery show *Elemental* features ceramics and fiber art. Open Fridays 5-8, Saturdays 12-6. June 27th will be the opening for a Street Art show, opening Monday from 5-8.

**Filling Vacant Board Positions / Trustee Elections — Gérald Checco.** Current board members Molly Gray and Monica Windholz have resigned because of time commitments and conflicts of interest. Current treasurer Tim Maxey would like to step down but still participate as trustee. New trustee replacements will need to be re-voted in November.

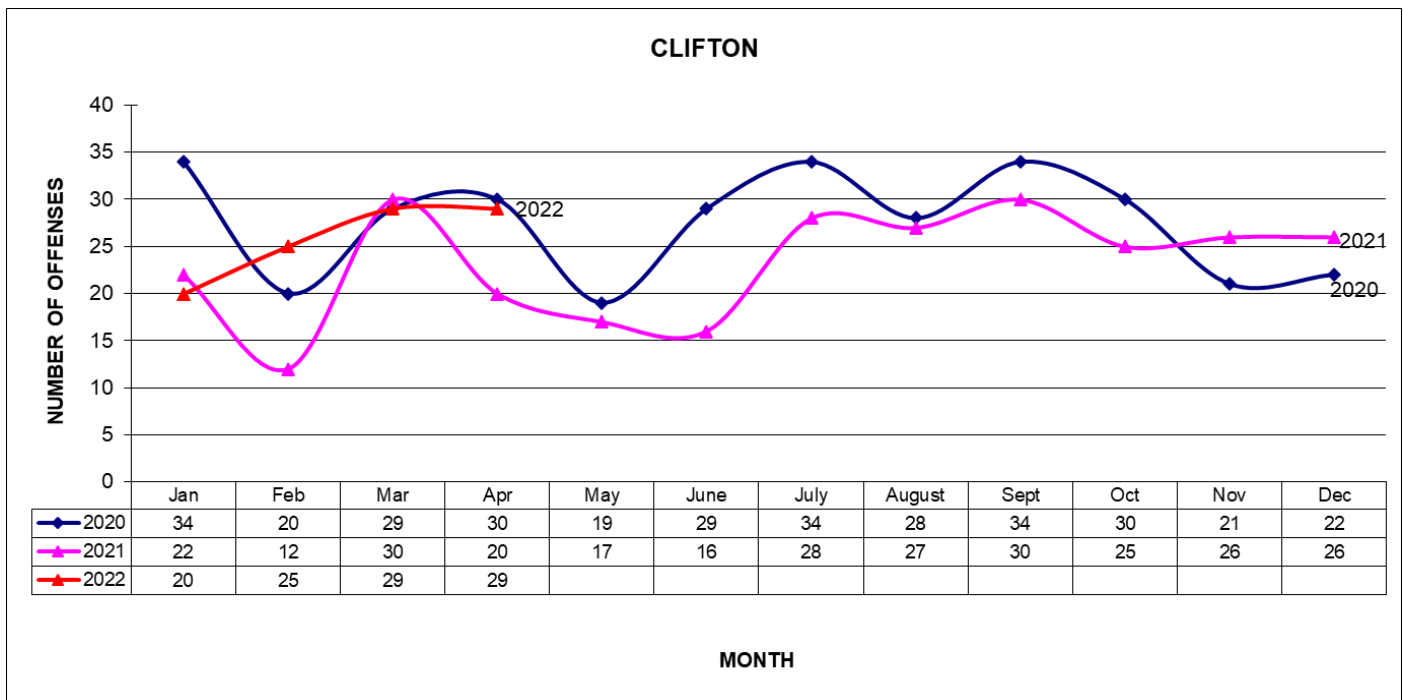

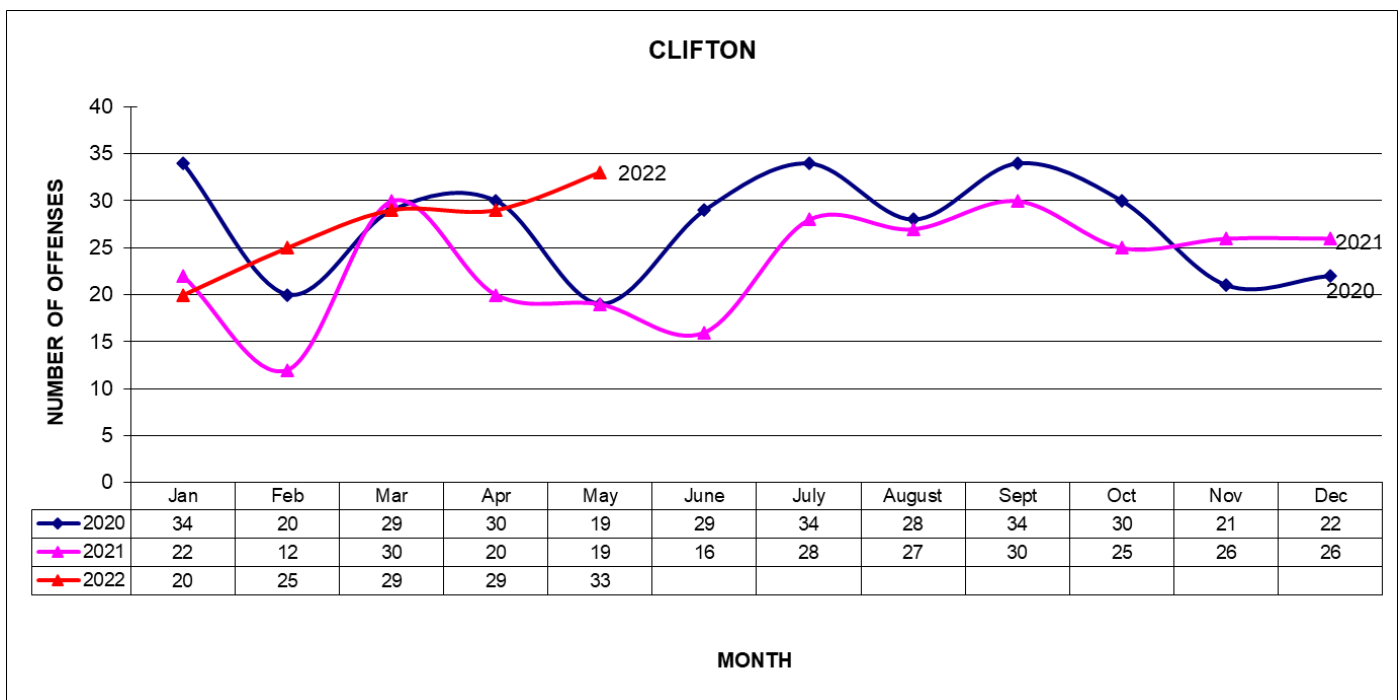

# Designated Outdoor Refreshment Area (DORA)

June 6, 2022

# What is a DORA?

In 2015, the Ohio State Legislature passed legislation that allowed for the creation of Designated Outdoor Refreshment Areas (DORAs)

In 2022, legislation was made effective to expand the number and size of DORAs within municipalities

DORAs allow any person who purchased an alcoholic beverage from a participating establishment to carry that drink within the DORA boundary

All other laws, rules, and regulations still apply

# What is a DORA? (cont.)

**ORC Section 4301.82**  
**CMC Chapter 838**

A DORA may not be larger than one contiguous mile

The City of Cincinnati may create six distinct DORAs

DORAs must be approved by City Council through an application and ordinance

DORAs must be renewed every five years

# Why have a DORA?

**A DORA can be an effective economic development tool to stimulate business growth within a community**

DORAs can help increase foot traffic and vibrancy within walkable business districts

DORAs not only support bars and restaurants but also retail spaces that allow DORA beverages within their establishments

# Cincinnati DORAs

## Current DORAs:

- The Banks – 85 acres
- Westwood – 13.8 acres

## Upcoming DORAs:

- College Hill – 25.5 acres
- Hyde Park – 7.9 acres

# What does the Application entail?

- Identification of the managing entity or “Manager” and an overview of the operations of the DORA
- A map or survey of the proposed DORA
- The specific boundaries, including street addresses
- A statement of the nature and types of establishments
- A statement of zoning / neighborhood plan compatibility
- Identification of at least four qualified permit holders
- The number, spacing, and type of signage



# Application (cont.)

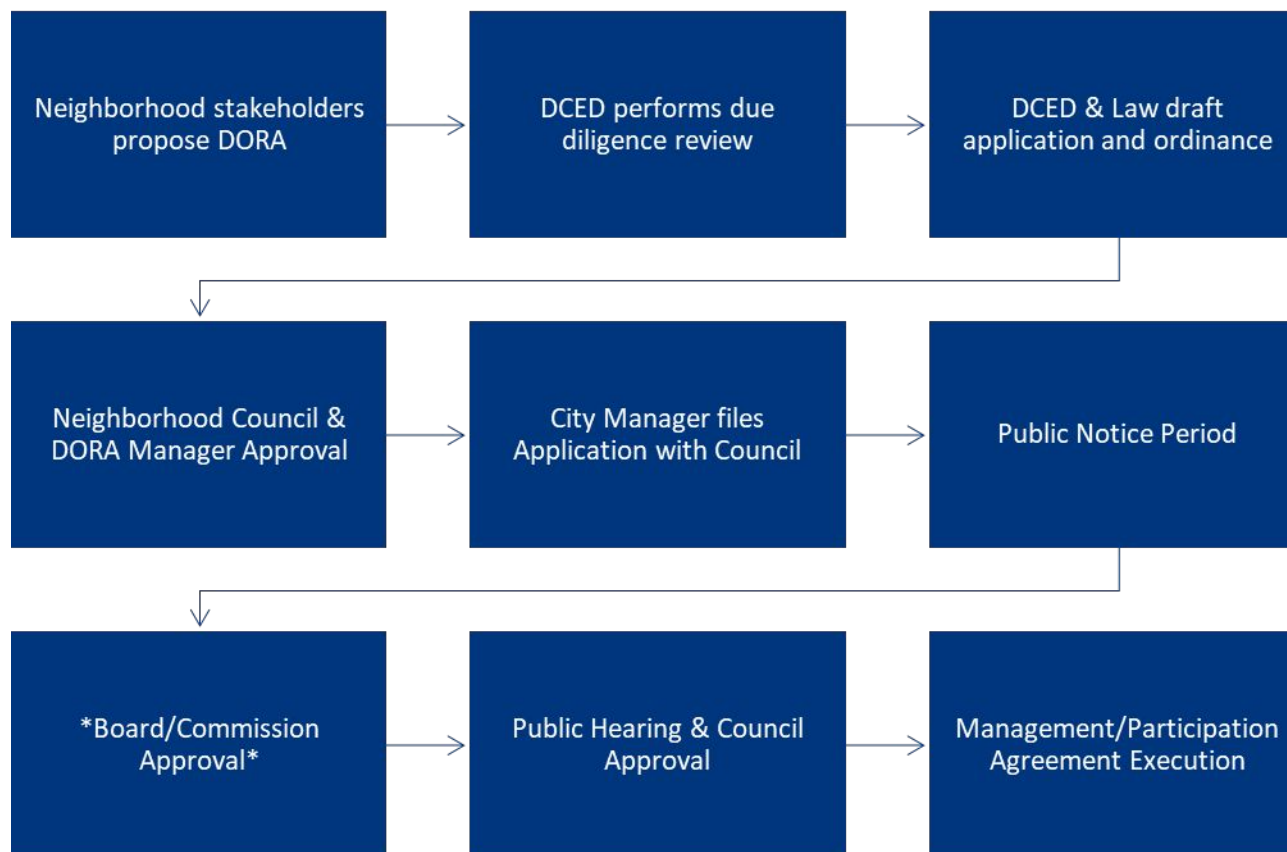
- The hours of operation for the DORA
- The number of staff needed to ensure public safety
- The number of staff needed to carryout the sanitation plan
- A requirement that beer/intoxicating liquor must be served in some sort of plastic bottle or container
- Letters and/or surveys of community support

# How Does a DORA work?

The City will enter into an agreement with the “Manager” of the DORA. The Manager shall have the following responsibilities:

- Promote and market the DORA
- Procure and sell DORA containers to establishments
- Enter into participation agreements with establishments
- Coordinate with special event organizers
- Ensure sufficient security services of the DORA
- Arrange for necessary supplemental sanitation services
- Provide and install signage as required and approved
- Complete annual reporting requirements
