February Meeting & Special Meeting Minutes – Jan moves to approve, Mary Pat Lienhart & Monica Windholtz second (U)

New Trustee Election — Gerald Checco presents two candidates to replace Chris Harding, who resigned last month. Barry Gee and Rachel Wells [Link to Bios](#)

Board members vote via online poll. Results: Rachel Wells is the new trustee for the rest of the year.

Zoning Density — Led by councilmembers Liz Keating and Reggie Harris, Nestor Melnyk

Keating: Zoning Density is a multi-faceted approach to move the needle on our city's housing crisis. Census shows 12,000 people have come to the City while 2000 housing units have been lost. The focus is on multi-family units and districts that have these today. Lift or double the density maximums to create naturally affordable housing. This also helps the budget by expanding the tax base and spreading out the costs. This supports small businesses by helping more people living within walking distances. Density helps with sustainability, desegregation, blight, historical context, and other benefits. This is a non-partisan approach—affordable housing impacts everyone.

Harris: This is a national problem. Supply has been under attack. Rent is going up 40+%. By lifting the density ordinance, we are allowing developers to build 8 units instead of 4. This incentivizes more 2 and 3 bedroom units and supports the folks who need housing subsidies. It allows developers to be more proactive...if the neighborhood cannot handle it from an MSD perspective, it won't get approved. Lifting of the density ordinance won't put undue stress on the infrastructure. This is not an affordable housing tool, it is an economic development tool. Lowering housing prices through supply and demand bring a more healthy and robust housing environment.

Housing & Zoning Committee statement: Jayme Ritter speaks on behalf of the committee, which doesn't support the current plan. The committee has held many discussions and worked with neighboring community councils. We are not opposed to an increase in density, but the current plan is broad brush and doesn't allow for looking at specific examples and usage. Hosea is an example of a street in Clifton where it wouldn't be appropriate to build more multi-family units at the proposed new density. The current plan is "one size fits all." We ask that the city work more at the neighborhood level, where there may be different density needs in different parts of the city. Nestor Melnyk adds that we are not against increasing the density, but the nuances are important here. Unilaterally doubling the density on everything that is not single family gave us concerns.

Discussion: Robert Hamberg asks about public transit and developer benefits. Keating states that more dollars are coming into public transit, so the focus is on public transit lines. Considering ideas from other cities to encourage use of buses and red bikes. This ordinance opens the door for more smaller multi-family developments (which would help smaller businesses). Larger development companies are less likely to look at these smaller projects, incentivizing smaller developments and businesses to invest in communities. Harris adds that further transit development will be coming as part of the overall vision.

Monica Windholtz raises concerns that doing zoning at the local level is not practical. Brendon Cull commends the council members for their work on the issue. He supports the issue, and suggests we not take a position tonight until there is further discussion beyond the H&Z committee's position today. There are good people on both sides of the argument and there is not clear consensus yet in the Clifton community. For example, there are 4 homes available for sale in Clifton right now and it is not as inclusive of a community as it should be. This is a minor

change and is not broad brush because it doesn't effect all of the Clifton's streets. Rachel Wells thinks it is not feasible to look street-by-street. It is not clear why some parts of the neighborhood would have different processes and rules vs. others. Robert Hamberg shares his perspective as a resident of Lowell, which is about 70% apartments. In areas where Clifton already has a sizable presence of multi-family properties, there are already advantages to increasing the density. For example, there isn't enough parking on the street, which new development could help solve for. Robert welcomes the changes and thinks it would be good for Clifton.

Nestor Melnyk adds some clarifications. Regarding concerns of unilateral, broad brush changes, there's no reason why maps couldn't be revisited and changed. By doubling the density and not thinking about how it impacts the community, we don't think it is a good idea. Monica Windholtz adds that we should follow up to see if our community is properly zoned, but that density and zoning are separate issues and discussions. Jayme Ritter agrees that zoning should be reconsidered. Carolyn Miller asks if it is true that if you increase the density you can lower the cost. She shared concerns about parking and the increase of cars due to increased density. Asks that parking be seriously considered as part of any plans. Kevin Marsh asks CTM to invest multiple meetings and community engagement on the matter.

Housing & Zoning does not take any specific action based on the discussion.

Closing Thoughts from Councilmembers: Councilmember Harris thanks CTM for the discussion. Adds that professional planners have gone through the zoning code carefully and has confidence in the city organization and their due diligence. Reducing zoning density was historically about keeping black, brown, and immigrant people out of certain communities. Taking a historical perspective is important here. Councilmember Keating adds that meeting with many neighborhoods and communities over the last year has been done. There have been two amendments made over the last year based on that feedback, for example for height restrictions and maximum density rules.

Treasurer's Report — Tim Maxey. We are updating our accounting software to Oracle's software. This is good software that has a lot of advantages—improving our tracking, visibility, and redundancy.

Jayme Ritter asks to review the January budget. Housing & Zoning committee is interested in a different allocation. Gerald Checco shares that the administrative budget items were combined and that the money is available.

Police Report — Officer Shawn Dent. Auto theft is up from last year (down vs. last month). There were two thefts on Cornell, one on Thrall. Officer Dent asks the community to increase its vigilance through emails and discussion. He is interested in Ring doorbell footage to help catch the individuals responsible for the thefts. Contact Officer Dent at shawn.dent@cincinnati-oh.gov

Brendon Cull asks for more information on speeding in our neighborhood, like citation data or other ways to show enforcement. Officer Dent shares that a lot of different neighborhoods have been asking for support on this topic. Recommends advocating for speed humps, speed enforcement can be done for a couple weeks, but is difficult to maintain consistently. Officer Dent offered to look into a speed wagon and will work with the traffic department.

Clifton Recreation Center Report — Collin Fitzpatrick. CRC has a lot of transition and thanks the committee for their patience. Offerings include fencing, pickleball, pottery, teen open gym, esports, woodcarving, ballroom dancing, board game meetup, yoga, and hip hop dance. Gearing up for summer camp. CRC will share their list of activities and events with CTM to help raise awareness of all their offerings. Contact Collin at collin.fitzpatrick@cincinnati-oh.gov. CRC is open Monday through Friday 7AM–8PM.

Library Report — Jeanne Strauss-DeGroot. As the pandemic is slowing, the library is trying to expand programming. Eric is adding another story time—first Saturdays at 11:00 for older kids (grades 1-3). It involves reading as well as arts & crafts activity. Registration is required. Virtual programs are available to help teens find summer jobs and related resources, including resume writing and interview skills. 1:1 sessions for teens will be offered as well. Register through the website.

Women's History Month is being celebrated at the branch. In April, we will celebrate national poetry month. Pauletta Hansel will offer workshops at the branch April 6,7,12. Poetry readings and open mic events will also be held. Working on some opportunities between library and Burnet Woods. Tax help is still happening at the library. Details are available on the website.

Burnet Woods Advisory Council — Lisa Haglund. Cleanup Cincinnati is a UC, student-led volunteer program. 30 students will work on cleanup and mulching. A spring wildflower hike will be led by Michael George on April 16th.

Communications Report — Monica Windholtz. Committee is looking for new, additional members. Social media is our most common form of communication, and we are looking into expanding email. Visit our website to sign up. Trustees and community members will use a form to submit content requests to help the committee get key information posted.

Jayne Ritter asks how we can make subcommittee meetings more visible to the community—H&Z meetings are the second Monday of every month. The committee is exploring a Google calendar to improve the community's visibility to events and meetings. Gerald asks that Facebook be open to the executive committee, based on the standing rules. Monica presents some risks to having multiple people posting and using communication tools.

Transportation Committee — Mary Pat Lienhart. Committee was approached by DOTE on a change in scope on the Central Parkway bike lanes. New proposal is to create a protected bike lane and asks for CTMs support.

Motion to communicate via email that CTM supports the DOTE change in scope from shared use path to protected bike lanes, by Mary Pat, second by Brendon. Vote (U)

Brendon Cull shares that he prefers to be off the road as a cyclist. The request is that we support a less expensive approach. By making a continuous bike lane they can reinvest in more bike lanes across the community. Mark Jeffreys is working on this and savings will help drive the greater plan. Robert asks for a plan to maintain and keep the lanes clean.

Memorial Day Picnic / Mt. Storm Advisory Council. We have not had many events for the last couple years due to the pandemic. It is time to revive some of these. Jan suggests that the Chronicle can be used to promote this. Brendon Cull supports it. Monica asks that a policy be used to decide if the pandemic levels should allow us to cancel. Jan adds that we can re-apply the policy used for Holidays on Ludlow. Genet Singh offered an idea to have an evening event at Clifton Market including a concert.

Motion by Gerald to establish a committee to start planning. Nestor seconds. (U)

Barry Gee

Hello CTM members! My name is Barry Gee, and I am seeking a Trustee position with Clifton Town Meeting. I have lived in Clifton since 2015 on the corner of Middleton and Wood in a house originally built for the Ibold family of Ibold Cigars, once a Cincinnati institution. My family and I love the great activities in and around Clifton such as CliftonFest, Burnet Woods and The Clifton Rec Center. Professionally I was an IT Project Manager for over 20 years and have been in semi-retirement since the pandemic hit. I have extensive volunteer experience and have served on boards for non-profits. I helped start an organization called Cincinnati Tomorrow in the early 2000s that focused on helping to retain young people in Cincinnati and help reverse the “brain drain”. I have also been a board member of the Cincy Blues Society and was the Director of Cincy Blues Fest for several years.

I believe the experience I have as a Project Manager and as an organizer would benefit me as a CTM Trustee. I look forward to working on issues related to traffic and safety, arts and culture and helping to plan the many events that make Clifton a special community. The work never ends to maintain Clifton as a desirable place to live and I look forward to helping respond to and manage the many challenges we face.

Rachel Wells

For nearly eight years, I have lived in a historic multifamily building on Jefferson Avenue, relying heavily on Clifton's accessibility to greenspace and multimodal transportation to live, work and play. To me, the ability to walk both through a dense canopy of trees *and* to a variety of arts and entertainment, dining, retail and educational establishments is the rare mix that makes Clifton unique.

In my work life, I have been a newspaper reporter covering local government and have served in communications and stakeholder engagement roles, including with a regional sewer and stormwater utility and an energy company. I currently work in a grant writing role for an education nonprofit and volunteer as a writer and proofreader for the Clifton Chronicle.

I would like to leverage the skills I've acquired through my experience in and around local government and infrastructure, and as a grant writer, to serve the Clifton community. I also believe my experience as a long-term multifamily resident would add a valuable perspective to the board of trustees.

It's important to me that all residents and visitors feel welcome, included and valued in Clifton. Throughout my career, I've worked to make systems more responsive to the communities they serve by building understanding and promoting civic participation. I'm eager to continue those efforts as a CTM trustee, and I hope I can help spread the word about all that's happening in Clifton while encouraging more Clifton residents to become CTM members. To that end, I would love to contribute to the communication and membership committees.

Expanding Housing Through Density

This ordinance would allow for the increase of land area/unit (density) limitations in the zoning code to allow for the construction of more housing within Multi-Family, Office, Commercial, Urban Mix, Manufacturing, and Riverfront Zoning in order to remove the barrier of the creation of housing in the city.

This proposal **does not** impact any other zoning regulations or development processes, with one exception regarding height restrictions.¹

This also **does not** impact single family zoning.

COMMUNITY ENGAGEMENT

Introduced last year, this ordinance has gone through a multitude of engagement sessions with public stakeholders, receiving feedback from the community, and ultimately improving the ordinance.

Over the last 10 years, Cincinnati's population has increased by over 12,000 people, but we've lost over 2,000 housing units. This ordinance will remove hurdles to investment and growth and will have a direct impact on small businesses and families throughout our city."

- All other regulations still apply:
 - Zoning requirements (height, setback, Hillside and Urban Design Overlay standards, stream corridor setbacks, etc.)
 - Local Historic District regulations
 - Building and Fire Codes

The Housing and Zoning Committee recommends that CTM take the following position on the proposed changes to the zoning regulations increasing density in all but single-family districts:

CTM recognizes that existing regulations present impediments to desirable development; however, CTM cannot support the Density Proposal as written at this time.

The proposal affects a significant geographical portion of Clifton and the character and quality of life therein. While development and higher density are desirable in some areas of Clifton and not others, this proposal does not provide for community-guided decisions and too little community review has been afforded.

Further, Clifton's community plan, which is in process, will give residents a voice in identifying appropriate development protocols that will be better tailored to our community and its physical characteristics.

The proposal uses existing zoning boundaries as a basis for the change, which do not provide for adjustment based on conditions within those zones.

CTM requests that the City take no formal action on this proposal without additional community input and analysis of specific impacts on each of the City's neighborhoods and the unique areas within those neighborhoods.

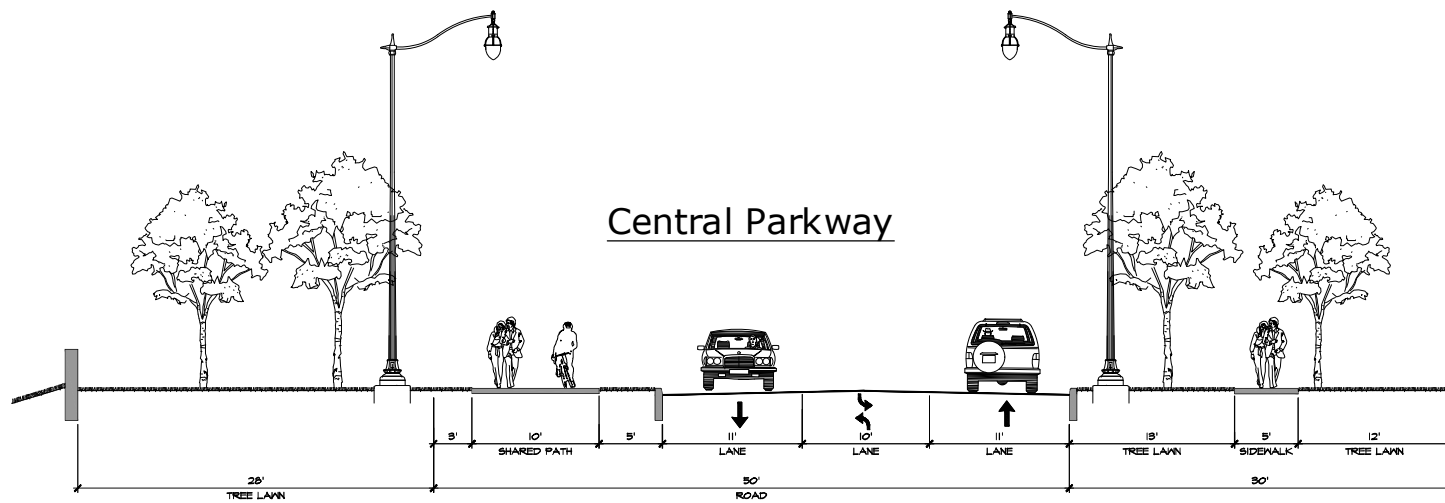

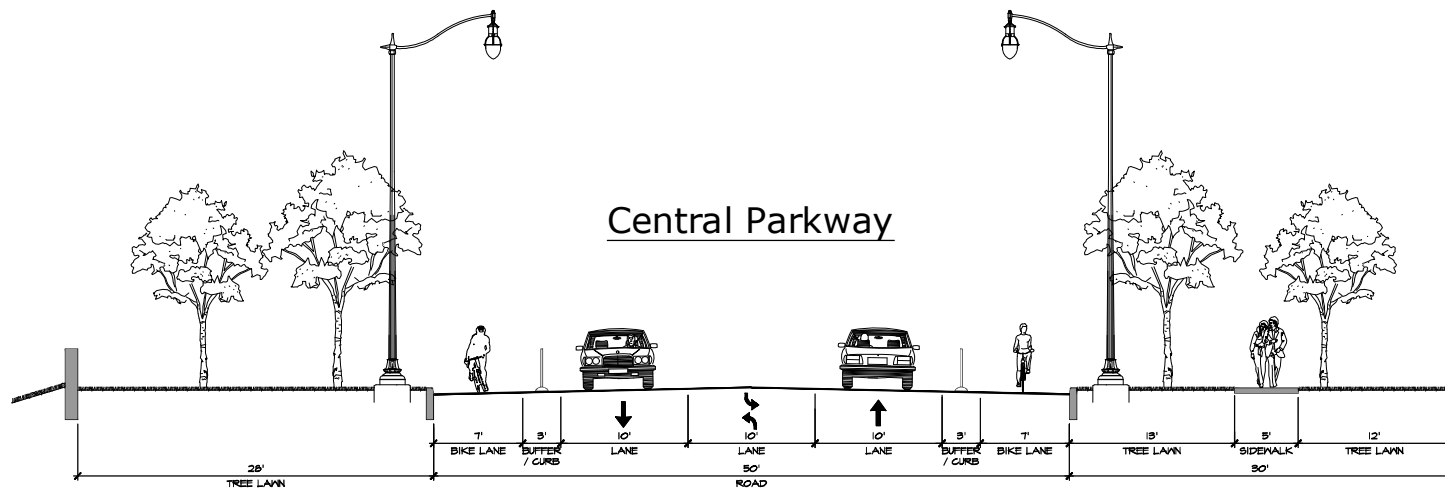
