Briefly describe the project and its impact in the NBD.

Vision: Clifton is a vibrant, safe, diverse community of residents, businesses and civic, educational and cultural institutions in a walkable neighborhood enhanced by public art.

Objective: Create a safer pedestrian environment to accommodate high levels of pedestrian traffic and a lively street life while reducing vehicular and vehicular/pedestrian accidents.

Goals: - Enhance pedestrian crosswalks at key. busy intersections

- Redesign key intersections to achieve a safer intersection with safer pedestrian crossings
- Create a safer pedestrian zone at and around schools
- Create a safer pedestrian zone around the new CCAC building
- Develop a safer business district setting along Ludlow Ave.
- Create space for outdoor dining with widened sidewalks and additional greenspace
- Use artistic interventions to slow traffic and mark pedestrian areas

Narrative: Clifton has a thriving business district, stable residential streets and a host of religious and cultural institutions, all adjacent to regional attractions such as UC, the Cincinnati Zoo, and the Uptown Hospitals complex. This brings vehicular traffic to and through the neighborhood which sometimes interacts negatively with the neighborhood's many walkers, resulting in accidents, near-misses and deaths. The relatively narrow sidewalks in the business district create an environment which is not ideal for walkers and shoppers. Additionally the schools in the center of the neighborhood and the soon to open Clifton Cultural Arts Center have brought even more children, families and individuals to Clifton's sidewalks and streets, making it evident that safe street crossings are inadequate.

Approach: Among Clifton's many creative assets are our art galleries, art centers and resident artists, as well as a tradition of producing public art and arts events. A problem-solving initiative is proposed to use pubic art solutions both on the ground plane and with vertical artistic infrastructure to call attention to sidewalk/street/intersection safety. Widened sidewalks, bump-outs, artistically painted crosswalks, protected pedestrian zones and at key intersections and neighborhood entrances might include banners, new plantings and other concepts which reflect the artistic nature and international spirit of Clifton.

Strategy: Other communities have demonstrated that artistically striking pedestrian zones can cause traffic to slow while creating safer and visually vibrant pedestrian areas which also enhance the local economy.

Working with the City Department of Transportation and Engineering and a citizen group organized by Clifton Town Meeting, the Clifton Business Association and the Clifton Community Fund, a series of potential improvements at several locations should be explored, with the idea of developing some pilot projects that can result in immediate improvements. Ideas developed out of this process would be shared and tested with the community,

followed by pursuit of grants to create several pilot installations at key sites, which, if successful, could lead to more permanent improvements.
